Appointment of Energy Services Company

Upon the recommendation of the Superintendent of Schools be it RESOLVED that the Board of Education appoint Johnson Controls, Inc. to provide and conduct an energy performance contract for the Three Village Central School District as stated in the attached resolution and pursuant to Section 9-103 of the NY State Energy Law; and furthermore, that the President of the Board of Education be authorized to execute an agreement with them.

On motion by Mr. Connors, seconded by Mrs. Mendelson, and carried by a 6-0-0 vote, the Board approved the resolution as presented.

Acceptance of Grant

Upon recommendation of the Superintendent of Schools, be it RESOLVED that the Board of Education accept a grant in the amount of \$50,000 (Fifty Thousand Dollars) from the Dormitory Authority State of New York (DASNY) to be utilized specifically for the restoration of historical artifacts at the Setauket Elementary School; approve the Grant Disbursement Agreement, and authorize the Board President to execute the Grant Disbursement Agreement.

On motion by Ms. Mendelson, seconded by Mr. Kornreich, and carried by a 6-0-0 vote, the Board approved the resolution as presented.
