

**DRIVER EDUCATION AND TRAFFIC SAFETY COURSE**  
**REGISTRATION INFORMATION**  
**FALL 2024**

A course in Driver Education and Traffic Safety will be offered at Ward Melville High School this fall for qualified residents of the school district.

Students will register by grade level. **Registration/Payment will be on Infinite Campus Parent Portal in the School Store as follows:**

1. **Incoming Seniors** – Class of 2025 – Wednesday, **August 21<sup>st</sup> at 10:00am**
2. **Incoming Juniors** – Class of 2026 – Thursday, **August 22<sup>nd</sup> at 10:00am**

**\*\* LIMITED ENROLLMENT \*\***

Students must be **sixteen years of age & have a valid NYS Learners Permit at the time of registration** in order to meet the age eligibility standard established by the State Education Dept.

**Date Course Ends:** *Thursday, January 22, 2025*

**Cost:** \$ 735.00     **Residents ONLY**

The following requirements and procedures must be completed for you to receive your Student Certificate of Completion (MV-285).

- ❖ You must complete the 48 hours of the program.
  - 24 hours of classroom instruction
  - 24 hours of in-car instruction (18 hours of observation and 6 hours behind the wheel)
- ❖ You must pass both portions of the program with a minimum grade of 65
- ❖ All homework, tests, reports that may be required must be completed & you must pass the final exam which will be administered during last class
- ❖ All students need a charged & working Chromebook for each class
- ❖ If classes are canceled due to inclement weather an announcement will be made on Google classroom.
- ❖ If your class is canceled a make-up date will be scheduled
- ❖ **YOU MAY MISS NO MORE THAN ONE (1) DRIVING LESSON AND ONE (1) LECTURE OR YOU WILL AUTOMATICALLY BE DROPPED FROM THE PROGRAM WITHOUT A REFUND. *Any missed driving & lecture classes must be made up***

- I have a valid New York State Learner’s Permit at the time of registration.
- I understand that I must successfully complete the theory and road portions of the course to receive a Student Certificate of Completion (MV-285)
- I understand that to successfully complete the theory and road portions of this course, my attendance is essential to fulfilling the state minimum requirements.
- **I understand that if I am absent more than one (1) time for a driving lesson or one (1) lecture class, I will automatically be dropped from the program. There will be no exceptions or refunds. According to DMV policy, FULL attendance is mandatory. If you have to miss one class (driving or lecture) due to illness or emergency, you must make it up. There will be one scheduled driving make up & one scheduled lecture class make up provided.**

I understand that to practice my driving skills without my driving instructor, all of the following conditions **must** be met:

- I have a valid New York State Learner’s Permit (MV-100)
- I practice only with my **Parent or Legal Guardian** between 5:00 a.m. – 9:00 p.m.
