Memorandum of Agreement

Upon recommendation of the Superintendent of Schools, be it RESOLVED that the Memorandum of Agreement – Contract, between the Three Village School Administrator's Association and the Board of Education be approved and authorizes the Board President and the Interim Superintendent of Schools to sign the agreement upon ratification by the membership of the unit.

Motion was made by Mrs. Peritore, seconded by Mr. Diviney, and carried by a 5-0-0 vote to approve the resolution as presented.

2011-2012 BUDGET

Program Reduction Review

Mr. Lederer presented updates to the proposed 2011-2012 budget cuts:

- District will receive \$500,000 in State Aid, an increase in what was previously expected.
- Bargaining Units retirement incentives will save the District approximately \$1 million.
- Propose that the Board consider raising the tax levy from 3% to 3.8% to save programs and generate \$1 million in revenue.
- Administration will review and finalize \$1.5 million in reductions to the budget and present at the April 12th Board meeting.

Mr. Diviney polled the Board for support of the proposed increase in the tax levy of 3.8%.

All members of the Board stated their support of a 3.8% tax levy contingent upon the administration's final budget proposal.

OTHER RELEVANT ITEMS No other items were presented.

MOVE INTO EXECUTIVE SESSION Mr. Diviney motioned to move into Executive Session at 9:40 pm in accordance with Open Meeting Law exempt items under FERPA (student disciplinary action), seconded by Mr. McIntosh and carried by a 5-0-0 vote.
